

V. FAILED PROPOSALS REVIEWED BY STYLE & DRAFTING COMMITTEE AND/OR LEGAL REVIEW PANEL

Of the 47 concepts and proposals presented, CRC approved 12 for further development and clarification through the Style & Drafting Committee. Of this number, 5 were reviewed by the Legal Review Panel. Four (4) were moved on to the public hearing process.

The following 8 concepts or proposals were considered by the Style & Drafting Committee and or the Legal Review Panel, but were not approved for public hearing. These 8 concepts and proposals received a great deal of public comment and discussion by the CRC members. The CRC members requested that this report provide information about "failed" proposals so that the Board of County Commissioners, municipalities and other appropriate organizations could take other action if interested. In many instances, it was felt that the changes needed could be more appropriately dealt with in a new or revised ordinance, administrative rules, etc.
