Mr. Jagrowski asked whether or not funding would be available for construction of the Dog Park and football field if the upcoming referendum passes. Mr. Ross stated that would be a decision the Brevard County Board of County Commissioners would have to make.

Ms. Breault verified that the lighting specifications had been met for the soccer, baseball and softball fields at Viera Regional Park.

Mr. Jagrowski requested that we have a ribbon cutting ceremony prior to Election Day for Pineda Landing Park. Staff will look into the possibilities.

Ms. Beasley recognized staff's efforts regarding the Grand Opening Ceremonies.

Mr. Malone asked if the grinder pump for the community building at Pineda Landing Park was under the parking lot and Mr. Ross replied that it was.

Mr. Moore informed everyone that Hurricane Wilma repairs were completed at Pineda Landing Park.

Ms. Breault stated that she is prepared for plant material whenever the Rotary Club is ready.
